- -Guaranteed Internet bandwidth should be 1000 Mbps (download/upload) with at least 5 public IP addresses
- -Provision of diagnostic reports and updates in case of connection failure
- -Provision of 24/7 monitoring facility available online that would show the historical and real-time performance of the internet service
- -Multi-Router Traffic Grapher (MRTG) for monitoring network devices and traffic
- -Provide 99.5% link uptime in a month (4 hours allowable monthly downtime)

- -Cabling to UITC Server should be provided by the ISP including rough-in
