Items Under Section I; Invitation to Bid

- The Scheduled submission and Opening of Bid Proposals will be on December 27, 2021 at 10:00AM.
- A complete set of Bidding Documents may be acquired by interested bidders on December 2, 2021 – December 27, 2021.
- Bids must be duly received through manual submission or electronic submission at the office address and/or e-mail address on or before December 27, 2021. Late bids shall not be accepted.
- All proposal for electronic submission must be submitted in *PDF format and password protected*. The password will be disclosed by the bidders only during the actual opening which may be done in Zoom.

Items under Section 2

- Sealing and Marking of Bids - Manual Submission.
 - Bidders shall enclose their original eligibility and technical documents in one sealed envelope marked **“ORIGINAL – TECHNICAL COMPONENT”** and the original of their financial component in another sealed envelope marked **“ORIGINAL – FINANCIAL COMPONENT”**. Sealing them all in and outer envelope marked **“ORIGINAL BID”**
 - Each copy of the first and second envelopes shall be similarly sealed duly marked in the inner envelopes as **COPY No. _____ - TECHNICAL COMPONENTS** and **COPY No. _____ - FINANCIAL COMPONENT** and the outer envelope as **COPY No. _____** “ respectively. These envelopes containing the original and the copies shall then be enclosed in one single envelope
 - All envelope shall:
 - Contain the name and the contract to be bid in capital letters
 - Bear the name and address of the Bidder in capital letters
 - Be address to the procuring entity’s BAC
 - Bear the specific identification of this bidding process indicated; and
 - Bear the warning **“DO NOT OPEN BEFORE...”** the date and time for the opening of bids

NOTE: 7 – Envelope system is required, but 10 envelope system will be accepted

Bid Security

- Use of standard format as prescribed by RA 9184

Eligibility and Technical Components.

- Bidders must attach a copy of Notice of Award, Contract, Notice to Proceed, and Certificate of Acceptance/Completion for their single Largest Completed Contract (SLCC)

Omnibus Sworn Statement.

- Use the standard format as prescribed by RA 9184

Item Under Section IV

2. Terms of Payment

2.2 Procuring Entity is allowed to determine the terms of payment on the partial or staggered delivery of the Goods procured, provided such partial payment shall correspond to the value of the goods delivered and accepted in accordance with prevailing accounting and auditing rules and regulations.

Payment of the contract price will be distributed for the one – year period.

Item Under Section V

Special Condition of the Contract

- Inspections and Tests to be conducted will include: *Speed Test, Bit Error Rate (BER) Test, Test for Packet Loss and Latency Test.*

Item Under Section VI

The delivery lead time period shall be within thirty (30) days upon receipt of Notice of Proceed

Item Under Section VII

- Guaranteed Internet bandwidth should be 150 Mbps (download/upload) with at least 14 public IP addresses dedicated account manager to provide a single point of contact.
- The service provider must provide its own facility and not rely on other providers to deliver the services.
- Installation/civil works shall be PVC for cable routing.
- Subnet is at least /28 for public IP address with at least 14 usable IP addresses.
